Our dental coverage is available in 2 stand-alone plan options, which can be obtained with or without a Kaiser Permanente medical plan. For you, this means more choices and better options. Benefits of our plans, which are available for all Federal employees, include:

- High or no benefit maximums
- PPO plan option
- Low premiums
- Low out-of-pocket costs
- Orthodontia and implant coverage with no waiting period

As a Kaiser Permanente dental plan member, you'll be part of one of the Northwest's largest dental plans with more than 160 dentists and 20 conveniently located dental offices. You'll also have access to our preferred provider organization (PPO) option, which includes over 7,300 dentists in Oregon and Washington.

Emergency dental care. If you have an emergency dental condition, dental care is available 24 hours a day, every day of the week. Just call the Dental Appointment Center and we will assist you. If you are outside of the Kaiser Permanente service area, some emergency dental services may be covered, depending on your dental plan. Please refer to the Plan Brochure, RI 73-004, for details.

We're growing to serve you better. We opened new dental offices in 2017 on the westside and eastside of Portland. In 2019, our new dental facility in Keizer, Oregon, will mean greater convenience in Salem with the addition of specialty dental services and 22 exam rooms. We will also be replacing our Beaverton Dental Office and making updates at other offices.

The dental plan for you

Choose from 2 dental plans with benefits designed to meet your needs.

Both plans include PreventaMax benefits, which means costs for preventive care do not count toward your annual benefit maximum. Preventive care such as oral exams, X-rays, routine cleanings, and fluoride treatments lead to better overall dental health.
